



## VI INTERNATIONAL SHORT FILM FESTIVAL

### Ciudad de Consuegra 2019

The City Hall of Consuegra aware of the importance of audiovisual media in Spanish society today, and trying to make them both a media and education, celebrated from 1-6 October 2019 the VI International Short Film Festival "Ciudad de Consuegra".

The Festival consists of a section: short film competition.

#### SHORT FILM CONTEST RULES

1. Participation in the short film competition is open to all the filmmakers over 16 years, both individually and collectively, provided that their nationality or residence is within the European Union.
2. The theme of the films is free and fiction, animation and documentaries will be accepted.
3. The length of the shorts may not exceed 30 minutes.
4. For selection, short films, regardless of their original format, will be delivered in DVD; Shipping will be at the contestant. Copies will be part of the Audiovisual Fund City Hall of Consuegra (Toledo) who reserves the right to reproduce, for use in cultural, educational and training activities, nonprofit.

They may also be submitted to the contest via the following specialized platforms in the world of cinema: [movibeta.com](http://movibeta.com), [festhome.com](http://festhome.com) and [clickforfestivals.com](http://clickforfestivals.com)

Regardless of the display mode, it is mandatory to attach the entry form. Otherwise the short film will be directly disqualified. For works submitted through the platforms will be valid record of such platforms provided they are compiled at least the same data as the tab of the festival.

Shipping costs of the work by any of the means chosen, be borne by the participant.

5. Movies can be silent or incorporated sound, still valid any of the official languages in the European Union; if not are in Spanish, they must have subtitles in Spanish.

6. Each participant may submit more than one job. The films must be later than 1 January 2018.

7. Each shipment author data it will contain clearly, photocopy of ID card or the like; sheet, filmography of the author, the cover and a brief synopsis of it. Send in digital format.

9. All work will be put out to tender deadline reception 14:00 on June 30, 2019. For digital platforms, the limit is also marked by number of entries, with the quota of 400 works submitted total.

10. The organization will pre-selection, which will be notified to the authors; Selected short films will share the projection during the exhibition as part of the official program of the competition. For screening may submit a DVD copy.

11. The Prizes are as follows:

JURY AWARD for Best Short Film, endowed with 1,200 euros

AUDIENCE AWARD for best short film, 500 euros

AWARD CASTILLA LA MANCHA, consisting of 500 euros for the best short film made in Castilla La Mancha, whether as creator, producer or whose theme seen on customs and traditions of La Mancha. (It must be specified that this prize is chosen, without prejudice of opting for other).

DOCUMENTAL AWARD for best short documentary endowed with 300 euros

ANIMATION AWARD, for Best Animated Short Film 300 Euros

EUROPE HONORIFIC MENTION AWARD, to the best short film of an European Union country, apart from Spain

To these amounts are covered by the corresponding withholding taxes required by law.

12. The jury will be composed of a group of people who decide the City Hall of Consuegra; the verdict is final, the jury can declare void any prize or modify award amounts.

13. The prizes will be awarded on Sunday 6 October 2019, within the Closing Ceremony Film Festival. At the award ceremony, the winner shall be present or his/her representative, and a video thanking the festival.

The festival shall not bear the expenses incurred for attendance at the awards ceremony.

14. Contestants will be responsible for the works presented are not subject to any legal claim.

Organizers assume people registering works hold the rights for exhibition of the works they register in the festival, as well as authorization to receive the prize. In any case, organizers waive to the responsibility that may be derived from breach of this term.

15. Participation in the festival assumes partial sharing of the film (no complete movie) on the official web, networks and Internet channels of the festival for spreading such, always mentioning their creators.

16. The organization reserves the right to modify any point of these rules if circumstances require; It would be made public.

17. Participation in this competition implies acceptance of its rules.
